3. Graywood Update:

- Building 2 will be complete Spring 2020. Total of units for Fish Creek Exchange is 820.
- Phase 2 (on East and West side of Shawnee Street) of development permits are split into 2 phases. Selling ongoing in phase 1. Grading and underground utilities installation has started. Building will start Summer 2020.
- Proposal for SE side is mixed use: rental, affordable (smaller units)/seniors' housing (up to 8 storeys potentially), commercial. Evaluating rental opportunities and additional commercial options to complete as fast as possible. Anticipating 4-6 years to sell out, 300 units on SW side, 100 on NW future site.
- Application for change to land use on SE site will be submitted by end of month to City.
 Anticipate 6 months for approval process. Redistribution of density: higher density closer to LRT on West side. Potential for a gas station/neighborhood amenities. This change is within traffic requirements.
- Graywood would look for a partner or sell to commercial developer for commercial area.
- Building 1 commercial spaces almost finalized: bakery, pizzeria and fitness provider.
