#### AGLC Casino Funds expenditure procedure

The Board was advised that AGLC holds the Treasurer and President accountable for ensuring that their policies and procedures are followed. This includes the requirement to have documented approval from AGLC for Casino expenditures before commitment for expenditure is made. In June it learned that although the AGLC likes to see money spent to benefit communities, saving casino funds for major projects is permitted. The casino bank account may reach \$500,000 before approval for an equipment project needs to be obtained and funds need not actually be spent until 24 months from the date that the \$500,000 balance is reached. In June, AGLC suggested and processed an update to our Use of Proceeds that allows us to hire qualified contractors for program delivery without approval for each new contractor and each new program.
